Well, T-cell response is critical, innate immunity is critical and it's the first thing that happens to people. The B-cells or antibody responses occurs several days later. For the antibody response to occur the T-cells have to be working. [mentions has papers to support:] The Pfizer and Moderna vaccines suppress the T-cell response in people that get the vaccine. The count of those cells go down, the chemicals they produce – interferon – interferes with the production of

viruses, T-helper 2 cells for making the right antibody response All of that is suppressed in individuals who get the vaccines.

30:06 Are the Vaccines Safe? Does not stay in the arm muscle – explains spread, explains vaccines viral load (exposure of billions of viral particles vs. natural infection (thousands of viral particles from a cough or sneeze), explains comorbidity factor – why people naturally infected were primarily getting and why healthy people are getting sick with mRNA vaccine

34:11 mentions 1970s 60 minutes documentary – exposing the lies by Big Pharma and the FDA on the swine flu vaccine and at 25 deaths they pulled it

35:02 animal research – You don't experiment on people unless you're a Nazi

35:48 As a physician, I've tried to call in to the VAERS reporting system. And I get a recording that tells me another telephone number to go to. 44:13 says if anyone can prove me wrong – go for it – but you're not going to because the beautiful thing about science is that we've conducted this in more than one site on the planet in seven different people with all three vaccines they all had the same devastating effect to the blood

44:51 Hypothesis as to what is happening – RNA or DNA when it is outside of a cell is a prion, human red blood cells are the only cells in the human body without a nucleus and they don't have ribosomes, they have hemoglobin to carry O2 and CO2. Red blood cells can't do anything with genetic code that's entered into it. The lipid nanoparticles would simply merge with the red blood cells. If the red blood cells behave like any other part of the body does when it's outside of a cell that doesn't have a nucleus or ribosomes when RNA or DNA comes into contact with it, it acts like a prion and changes the protein structure. Hemoglobin is a protein. It looks like these vaccines are releasing into the red blood cell having a prion effect on the hemoglobin molecule – permanently changing it so it no longer has the same shape of configuration so it can't bind to oxygen and it won't be able to pick up carbon dioxide either

50:36 There comes a time for everyone to be held accountable for things that they do. People make mistakes. I'm human. You won't have any challenges finding someone that will tell you that I make mistakes, okay? I know I make mistakes. I'm my worst critic on a science and medical perspective. Two decades worth of gain of function research all focussed on increasing the infectivity of this virus with consequences that are very clear around the world. We took procedures in 2020 and 2021 that make no scientific sense. Many of them did it because they were told there were no treatments and who told them that? Agencies out of the federal government? A federal government run by Fauci, Collins and other people. Those agencies don't practice medicine. You don't call them when you go to the hospital. Your physician practices medicine.

52:07 We have interfered with physicians feeling like they could practice medicine. For the physicians who have not bothered to measure treatment outcomes but are espousing the treatments of drugs, I encourage them to get the quantified measured data.

52:34 I was there when HIV hit the scenes, we didn't know what we were doing. So, we worked, we winged it. We treated symptoms.
