

## Trudeau Enacted EMA; Incident Response Group Said Unnecessary; A Political Opportunity?

https://www.lifesitenews.com/news/secret-notes-reveal-trudeau-wanted-to-use-emergencies-act-despite-cabinet-members-saying-it-was-unnecessary/ According to Blacklock's Reporter, confidential minutes from cabinet meetings show Trudeau had set up "the conversation to discuss two possible tracks" that were "1) actions that could be taken under existing authorities and 2) the process of invoking the Emergencies Act."

The minutes are dated February 10 and come from an Incident Response Group cabinet meeting that lasted about two hours. At the meeting were 45 people, including Attorney General David Lametti and Royal Canadian Mounted Police Commissioner Brenda Lucki.

Cabinet invoked the Act days later on Monday, February 14.

The first known reference to the Act is cited in ten pages of censored cabinet minutes marked "secret." The document indicates Trudeau was told most protesters, as many as 95 percent, were weary of the three-week protest and prepared to leave. The confidential February 10 meeting lasted two hours. Forty-four people attended including RCMP Commissioner Brenda Lucki and Attorney General David Lametti, the Prime Minister's chief of staff and his director of communications.

2012 – Justin Trudeau announces he's running for Liberal party leadership on October 2, with Katie heading his campaign. Six months later, he's officially elected to the position. 2015 – Serves as Trudeau's campaign co-chair and director during the federal election (the longest in modern Canadian history, at 78 days) and helps him achieve a majority government coming from a third-place position in the House. Katie becomes the 15th Chief of Staff to the Prime Minister — and just the second woman to hold the title — assuming office on November 4

"I'm Katie, I'm chief of staff. We have one exception to the no-boys rule today," she says, looking toward her lightly freckled son, George, who smiles back up at her... she's determined to make good on one particular promise from the Liberals' 2015 election campaign platform: to make Ottawa a place where the numbers of men and women around any given table are equal. A place where someone like her wouldn't keep a tally in a notebook... To make this lunch meeting, she took a red-eye from Vancouver, after having attended a soiree with billionaire philanthropists Bill and Melinda Gates in Seattle... At one point, Telford turns to George and wryly says, "You're going to be a raging feminist, aren't you?" Back in the early '90s, when then-Ontario NDP premier Bob Rae had an important guest over for dinner, he would sometimes ask his young neighbour, Katie Telford, to watch his dog, a cockapoo named Cindy. Telford, the daughter of Peter and Phyllis, both public servants... Telford credits her politically powerful neighbour, the man who would also drive in the carpool for orchestra practice (she played violin), with inspiring her to get into politics, "whatever the party."... She went on to study political science and history at the University of Ottawa and found a natural home for her public speaking chops in the nerdy world of university debating — a sphere also occupied by Gerald Butts, now principal secretary to the PM and her daily co-conspirator... She was adopted into a small clique of the few other female chiefs of staff for Ontario ministers who called themselves the "Power Chicks" (remember, it was the early 2000s). When Telford became chief of staff to the prime minister, they gave her a pen engraved with their now somewhat cheesy group name — it sits in a case on her desk in the PMO.

Lickspittle #2 - Director of Communications: Cameron Ahmad





Canada. As press secretary for the Office of the Leader of the Liberal Party of Canada, he deals with the Ottawa Press Gallery as well as media across the country on a daily — often hourly — basis. Just a few credits shy from graduating, Ahmad postponed his final semester as an undergraduate student in the Department of Journalism to hop on the campaign trail. He took time out of his hectic schedule to talk about what it's like being press secretary to a Canadian

party leader smack in the heart of a federal election. How did you get involved with the Liberal Party of Canada? The Liberal Party has a very active youth wing. I got increasingly involved during university, heading up the Concordia branch of the Young Liberals of Canada and eventually their Quebec chapter. I joined the Young Liberals at a time when the leadership race was engaging many Canadians in the political process for the first time — particularly young people and students. That gave us a tremendous opportunity to reach out to universities and colleges across Quebec. I'm proud to have played a meaningful role in getting other students directly involved with politics. We saw a real impact, as our membership more than doubled in less than two years.

Although it is possible that iterations of this group have met on other occasions, Monday marked the first time the government publicly announced a meeting.

Prime Minister Justin Trudeau convened an "Incident Response Group" meeting Monday morning featuring Freeland and other undisclosed ministers.

Trudeau announced its formation Aug. 28 (2018) along with a shuffle of cabinet committee members. It's described as "a dedicated, emergency committee that will convene in the event of a national crisis or during incidents elsewhere that have major implications for Canada."

The committee was billed as something similar to what Five Eyes allies — the United States, the United Kingdom, Australia and New Zealand — already have in place within their own governments. A ministerial-level meeting among the Five Eyes was being held the same day as the announcement.

Committees have their own members and areas of responsibility, which are set by the Prime Minister. The Treasury Board is the exception, as its mandate and membership are established in law. The current Cabinet committees include:

Incident Response Group - Serves as a dedicated emergency committee in the event of a national crisis or during incidents elsewhere that have major implications for Canada. Responsible for coordinating a prompt federal response to an incident, and making fast, effective decisions to keep Canadians safe and secure, at home and abroad.

Members - The Incident Response Group is a working group of ministers. Membership of the Group may consist of relevant ministers and senior government leadership, as needed, based on the nature of the incident.

Through Cabinet and its committees, the Prime Minister provides ministers with the principal forum in which they can resolve different perspectives. WHAT DIFFERENT PERSPECTIVES?? Ministers must also consult caucus on policy and expenditure proposals. Ministers have the right to seek their colleagues' consideration of proposals that may impact their area of responsibility.

Confidences of the Queen's Privy Council for Canada, more commonly referred to as "Cabinet confidences", must be appropriately safeguarded from unauthorized disclosure or other compromise.

Today, Prime Minister Justin Trudeau convened the Incident Response Group.

The group discussed Canada's response to the Novel Coronavirus, including actions taken to keep Canadians safe and prevent the spread of the virus. Minister of Health Patty Hajdu and Canada's Chief Public Health Officer Dr. Theresa Tam updated the Prime Minister on our preparedness and the second presumptive case of the virus in Canada. Discussions highlighted the work being done with partners and across government – including by Transport Canada, the Public Health Agency of Canada, Global Affairs Canada, the Canada Border Services Agency, and Public Safety Canada's Government Operations Centre – to ensure the best possible response to the coronavirus.

The Prime Minister and members of the Incident Response Group also discussed Canada's ongoing efforts to help families affected by the Ukraine International Airlines tragedy in Iran. They also discussed the status of our support for Australia as it battles bushfires, which includes on-site Canadian civilian firefighters and fire management experts. The Canadian Armed Forces are also providing satellite imagery and airlift support to Australia.
